ANNOUNCES THE 14th ANNUAL RECEPTION AT WEFTEC.2017

The PWEA's 14th annual reception will be held on **Sunday, October 1, 2017, 4:30-6:00pm**, at the WEF Headquarters hotel, the **Hilton Chicago**, during WEFTEC.17 in Chicago. This will be a joint reception with the Chesapeake Water Environment Association. CWEA members will be invited to attend the reception, along with PWEA members.
