Archaeologists explore ancient stormwater tunnels beneath Pompeii

Ongoing expeditions into the ruins of Pompeii continue to reveal new details about the ancient Roman city and its people, believed to have been decimated by the sudden eruption of nearby Mount Vesuvius around 79 CE. Archaeological Park of Pompeii (APP) researchers have spent two years uncovering new details about how ancient Pompeian engineers approached stormwater management. They surveyed 457 m (1500 ft) of stormwater tunnels that once carried runoff from the city's center toward the Bay of Naples. APP is now working to restore functionality to the ancient tunnels while respecting and preserving their historical value. Take the WEF Stormwater Institute's 2020 MS4 **Needs Assessment Survey**

In 2018, the Water Environment Federation (WEF; Alexandria, Va.) Stormwater Institute polled more than 600 Municipal Separate Storm Sewer System (MS4) permittees in the first attempt of its kind to identify common challenges and needs among the diverse array of U.S. stormwater managers. Results of the survey, released in May 2019, underscored broad needs for dedicated sources of funding, infrastructure renewal or replacement, and clearer regulations among respondents. Phoenix, Ariz., hosts inaugural Stormwater **Awareness Week**

The messaging was part of the City of Phoenix Water Services Department's (WSD) inaugural Stormwater Awareness Week, a campaign aimed at raising the profile of local issues related to flood prevention and runoff pollution mitigation.
