



Training Advice for Individuals Seeking Wastewater Certification

There are many resources available to help you prepare for the wastewater system operator certification examinations. We encourage individuals to seek classroom training as opposed to relying on self-study. It is recommended that you brush up on basic math, biology, and some chemistry.

Certificate Programs

A certificate program is an entire curriculum or series of DEP- approved courses that prepare an individual for the operation of a treatment plant. A DEP- approved certificate program is comprised of at least 180 hours of approved courses. Individual courses and modules within the overall certificate programs may also be taken if offered by the college, rather than completing the entire program. Currently, there are five DEP- approved certificate programs for wastewater:
